Investment Strategy

The Sharia Compliant Growth Investment Strategy from Mubasher is designed for Aggressive investors who wish to invest in a range of high quality sharia compliant mutual funds. The returns subject to market conditions are expected to provide growth materially in excess of inflation. Investors should expect the value of investments to fluctuate significantly from one year to the next. Based on the market historical returns; over the long term, the value of investments is likely to fall in more than one individual year. Returns, if higher in other years are expected to-compensate for such falls.

The performance illustration shown do not indicate guaranteed returns and is only an example of what the performance of the Strategy would have been had it been operated for the past 5 years.

The performance assumes semi-annual rebalancing and that the constituent funds were not changed over the period.

The benchmark is a Morningstar category average of Aggressive allocation portfolios which typically have 70% to 90% of assets in equities and the remainder in fixed income and cash.

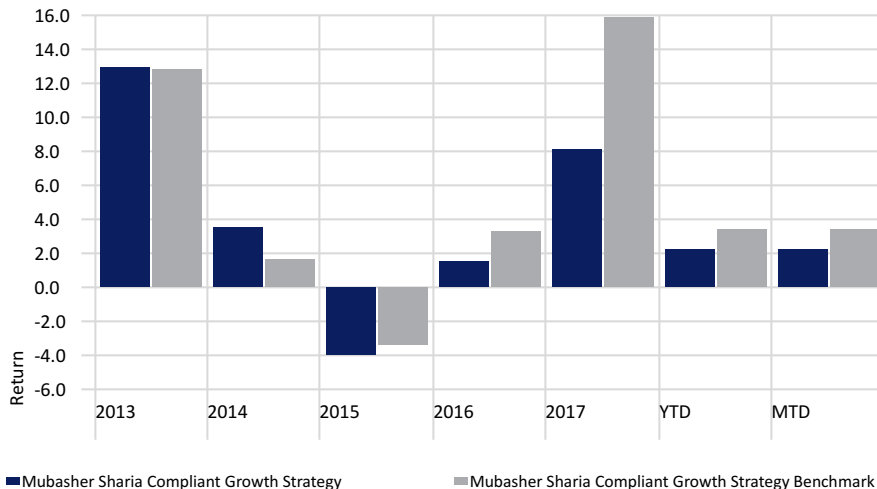

Time Period: 2/1/2013 to 1/31/2018



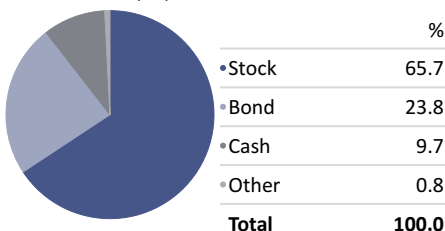
